About the Collaborative Research Center - SFB 700

The SFB 700 "Governance in Areas of Limited Statehood: New Modes of Governance?" was a Collaborative Research Center funded by the German Research Foundation - Deutsche Forschungsgemeinschaft (DFG) – over a time span of twelve years. Five institutions supported the research center: the Freie Universität Berlin, the University of Potsdam, the German Institute for International and Security Affairs (SWP), the Berlin Social Science Center (WZB), as well as the German Institute of Global and Area Studies (GIGA). Furthermore, the SFB 700 launched a project in cooperation with the German Federal Foreign Office (AA) aiming at a mutual exchange of knowledge in the context of foreign affairs.

Some 60 scholars were involved, most of them political scientists, historians, and legal scholars. By working together, they were expanding the borders of their respective institutions to discuss global questions regarding governance in areas in which state authority is limited or completely lacking. 17 individual research projects covered a broad variety of topics around the globe. Examples include research on exchange relationships and collective use of resources in culturally heterogeneous areas in Latin America, (local) security practices in Africa, peacebuilding after the violent conflict in Afghanistan and historical perspectives on governance in China from 1949 until 1957.

The SFB 700 officially closed on 31 December 2017. However, the researchers that have been involved in the research center and our international network will continue to study governance in areas of limited statehood. Other research projects such as the EU's Horizon 2020 project "Europe's External Action and the Dual Challenges of Limited Statehood and Contested Orders" will keep working on the subject. We look forward to continue researching this fascinating topic with you!

About the Kolleg-Forschergruppe "The Transformative Power of Europe"


"The Transformative Power of Europe"

The Kolleg-Forschergruppe (KFG) is a funding program launched by the German Research Foundation (Deutsche Forschungsgemeinschaft – DFG) in 2008. As a Research College, it is intended to provide a scientifically stimulating environment for innovative research within a small group of senior and junior researchers.

The KFG "The Transformative Power of Europe", directed by Tanja A. Boerzel and Thomas Risse, investigates how ideas spread across time and space. During its first phase of research, from 2008-2012, the KFG studied the diffusion of policy ideas and institutions within the European Union (EU), its candidates and neighborhood. During the second phase, from 2012-2016, the KFG has realigned its focus of interest on the diffusion of ideas, policies, and institutions beyond Europe (comparative regionalism) and the analysis of the EU at the receiving end of external influences.

The KFG has engaged in a wide array of activities to develop its research agenda and foster knowledge exchange among scholars and practitioners. The activities of the KFG have resulted in numerous publications, including monographs and edited volumes by its directors and visiting researchers, as well as its Working Paper Series.

The KFG is closing with a last international conference, taking place in Berlin in mid-2018. Nevertheless, the large scientific community that emerged out of the Research College, will stay around and the discussion on its research topics will continue.
